 - Proposed and Amended Mission Statement (Laura) (Discussion) Update mission statement to sound more educational for a better chance of getting 501c3. **New Mission statement to read:**

To preserve and improve water quality, fish habitat, and the well-being of wildlife in our lakes and the watershed of which our lakes are a part.

To encourage and participate in activities intended to prevent the emergence of aquatic invasive species in our lakes and the watershed and, if such emergence occurs, to control the growth and expansion of such species.

To educate our members and other members of the public on proper conservation practices relating to the above purposes.

 Proposed 501(C)3 & Amended Bylaws Review (Gary) Changes to make us more of a non-profit than a homeowners assoc. New mission state will be inserted into bylaws. Looking for 60% of today's membership to change.

Items updated:

- Membership has responsibility to update Association with current mailing address. This will be primary mode of communication.
- Annual dues changes can be approved by board of directors (BOD)
- Sect 2 C NEW, Members may wish to gift larger sums of \$ or land, BOD has authority to accept
- BOD may establish rights of members
- Members cannot claim ownership of property owned by Association
- Association will not sell members info
- Resignation of member no membership dues refunded
- Issues resolved by simple majority at meeting bylaws exempt
- BOD shall be no fewer than six members, no compensation, two-year term (up to five consecutive terms), must be a member of good standing.
- BOD shall meet 4 times a year with a 2-week notice to members. Dates published in newsletter and on website
- A quorum is 6 voting board members voting done in person, via phone, via electronic communications
- Adding Secretary and Membership chair to Executive Committee
- Resignation from BOD must be in writing.
- Termination from BOD for two **unexcused** absences in a year
- Sec 10 adding for items that need immediate attention. Action can be taken without a meeting.
 Action sent out via mail or email. voting can be done by same method
- Established an Executive Committee President, Vice President, Secretary, Treasurer, Membership Chair. Quorum is 80%
- Finance define fiscal year as January 1 December 31. All debts must be approved by BOD.
 Authorized signer is President.
- Bylaws may be amended by 60% of voting members currently at meeting

LegalCorp is non-profit helping with bylaws and non-profit status. May need to change name to sound more educational. If vote to amend bylaws, sub committee will continue to change Articles of Incorporation (Discussion)
