

Water Quality Sampling Season Wrap-Up

As the 2025 water quality sampling season concludes, we want to extend our sincere gratitude to the volunteers who made this vital work possible. Special thanks go to Brian Laudenbach (Kid Lake), Gary Rueter and Kobe Pozzani (Lost Lake), Randy Turnacliff (McKeown Lake), Jo and Gary Guttormson, Pam and Todd Willis (Man Lake), and Mike Schmitt (Baby Lake). Your dedication to monitoring and protecting our lakes' health is truly invaluable.

Between June and September, the team collected five water samples from each lake, along with Secchi disk readings to measure water clarity (pictured right). All samples were promptly delivered to RMB Labs for analysis. This testing occurs every other year as part of the lake association's ongoing effort to monitor and preserve the quality and health of our lakes.

The samples are tested for essential indicators such as phosphorus levels, chlorophyll-a concentration, visual depth, and overall water clarity. These factors help us understand the ecological balance and detect any early signs of environmental stress. Although weather conditions were challenging at times, the team's perseverance ensured a successful sampling season.

We were also excited to welcome new volunteers this year. They quickly learned important sampling procedures, including the critical task of properly labeling sample bottles—an essential step that ensures accurate identification and reliable results throughout the testing process.

RMB Labs is currently processing this year's samples. The results will be available on the Lake Association website at www.our6lakes.org. The report will provide valuable insights to guide our ongoing lake conservation efforts and inform future initiatives.

Thank you once again to everyone involved this year and past years. Your hard work and commitment has helped safeguard the natural beauty and ecological health of our lakes for generations to come.

Pumpkin Cranberry Bread

Cook's Notes: Pumpkin bread or cranberry bread? What's your craving? How about the best of both worlds with this pumpkin cranberry bread with walnuts? Moist and tender, and not too sweet, it's the perfect accompaniment to a cup of coffee or tea or as an afternoon snack. The recipe is adapted from whatagirleats.

Ingredients

- 1-1/2 cups all-purpose flour (gluten-free flour may be substituted)
- 1 teaspoon baking soda
- 1/4 teaspoon salt
- 1/2 teaspoon baking powder
- 2 teaspoons pumpkin pie spice mix
- 1 teaspoon ground cinnamon or 1/2 teaspoon Saigon cinnamon
- 1/4 cup sugar
- 1/4 cup dark brown sugar, packed
- 1 cup canned pumpkin purée not pie filling
- 1/2 cup buttermilk
- 2 tablespoons vegetable oil, coconut oil, or another neutral oil such as canola
- 2 large eggs
- 1 cup frozen cranberries, halved
- 3/4 cup chopped walnuts



Directions

Preheat oven to 375 degrees.

Grease with PAM a 10" loaf pan.

Mix all the dry ingredients in a large bowl using a whisk.

Mix the following ingredients (white sugar through eggs) together in a mixer until well blended.

Add flour mixture to the pumpkin mixture. Stir just until blended. Avoid overmixing the batter.

Mix in halved cranberries and walnuts. Pour the batter into the prepared pan.

Bake the bread in the center of the oven at 375 degrees for 45-50 minutes for the loaf pan or until a toothpick inserted into the center of the loaf comes out clean.

Allow the loaf to cool completely on a wire rack. Wrap extra bread in plastic wrap and refrigerate until needed.

As nature's 'ecosystem engineers,' beavers could help fight effects of climate change

Beavers, as "ecosystem engineers," offer significant environmental benefits that can help combat climate change, despite often being seen as pests in Minnesota. Their dams slow water flow, reduce flooding, improve water quality, and create biodiverse wetlands that can even resist wildfires due to their constant moisture.

Emily Fairfax, a University of Minnesota beaver researcher, highlights beavers' powerful ability to reshape landscapes, second only to humans, and their tireless dam maintenance driven by survival. Beaver-created wetlands also provide crucial habitat and increase water storage, enhancing resilience to droughts and floods.

Recognizing these advantages, states like Minnesota are slowly shifting towards beaver restoration and nonlethal management, moving away from trapping and killing problem beavers. The St. Anthony Falls Laboratory is opening an outdoor stream channel for research on beaver dam hydraulics and their response to environmental stresses, fostering coexistence strategies. Fairfax believes that by understanding and strategically working alongside beavers, rather than clashing, we can leverage their natural abilities as a hopeful and effective solution to climate challenges.


